Enrichment, Extras & Essentials

Government funding only covers the cost of the provision of childcare and the delivery of the Early Years Foundation Stage (EYFS).

The funding does not include any of the additional services that our nursery provides, which include:

- Enrichment activities:
 - Heath School Sessions £90
 - Dance/Drama Sessions £80
 - Language Sessions £90
- Access to our parent app £22



We therefore ask parents to pay for these with our 'Enrichment, Extras & Essentials' fee, which is **£282 termly**.

Whilst this charge remains voluntary, if parents decline to or are unable to pay the 'Enrichment, Extras and Essentials' fee they will need to speak to our Admissions Manager to discuss further.

Funded Entitlement Only Places

We offer Part Time Funded, or Funded Entitlement Only (FEO) places which are subject to availability and offered for select sessions. Access to these places is determined based on need and in line with our Government Funding Policy.

FEO places are not required to pay a registration fee or deposit.
